Jernigan, PT, Ph.D., FNAP, was appointed Director of the DPT Program in the Department of Physical Therapy and Rehabilitation Science at the University of Kansas Medical Center (KUMC) in March 2017 and teaches the Applied Anatomy and Kinesiology courses for the program. In addition, one of his primary roles is to coordinate and participate in the interprofessional education (IPE) and practice activities that are integrated throughout the DPT curriculum at KUMC.

Dr. Jernigan's research focus is IPE. He is heavily involved with KUMC's Center for Interprofessional Education and Simulation as a co-lead for both the Curriculum and the Assessment and Scholarship Committees, and is the Director of the School of Health Professions' IPE Workgroup. He is the Principle Investigator for the required, campus-wide interprofessional collaboration foundational education program and has developed an umbrella research protocol to facilitate exempt level IPE research at KUMC.
