


ACAPT Action Decision Tree

Committee

A committee is a group of individuals who are appointed by the ACAPT BOD or an ACAPT consortium. Committees focus on ongoing priorities that are critical to the organization's mission, vision, or strategic plan or that of those related to the consortium. Committees consist of individuals from ACAPT member institutions. The individuals are appointed by the ACAPT BOD or Consortium Board of Directors based on recognized expertise or through an official call for volunteers.

Consortium

A consortium (comprised of "Individual Members" of ACAPT member institutions as defined in the ACAPT bylaws) is a forum to explore, exchange and pursue ideas around an identified area of mutual interest in academic physical therapy. While each consortium has an appointed Board liaison to facilitate communication with the Board and components, consortia do not hold voting privileges at ACAPT business meetings. Task Force

A task force is a group of individuals appointed by the ACAPT Board of Directors to complete a specific charge or objective of interest to the enterprise of academic physical therapy. Task forces are typically composed of ACAPT members, but may include representation from other communities of interest. An ACAPT Board member will be assigned as a liaison to the task force. APTA Staff and/or a consultant could be asked to serve on or assist with an ACAPT task force, as needed. The Chair organizes the work of the task force, recording meeting notes or minutes of meetings/conference calls, and submitting reports to the ACAPT Board.

Clinical Ed Panel

A Panel is a group of individuals appointed by the ACAPT Board of Directors to complete a specific charge or objective of interest in response to or related to the recommendations from the Summit. Panels are typically composed of ACAPT members, but may include representation from other communities of interest. An ACAPT Board member is assigned as a liaison to a Panel. APTA Staff and/or a consultant may be asked to serve on or assist with a Panel, as needed. An addition or alternative to a consultant is to have a volunteer identified as a facilitator to oversee the work of multiple Panels in which the objectives have outcomes that correlate. The facilitator assures that the chairs of the multiple Panels are aware of each other's work and are coordinating activities so the outcomes are distinct but interrelated. The Chair organizes the work of the Panel, recording meeting notes or minutes of meetings/conference calls, and submitting reports to the ACAPT Board.

Workgroup

A work group is a group of individuals from the ACAPT Board of Directors assigned to complete a specific charge or objective related to governance and administrative matters of ACAPT. Membership on work groups may also include other individuals from ACAPT and/or consultants. Work groups are responsible for identifying a leader to organize the work of the work group, recording meeting notes or minutes of meetings/conference calls, and submitting reports to the ACAPT Board.
