She is currently serving as Vice-Chair on the National Consortium of Clinical Educators and previously served a 2-year term as an Academic Director-at-Large. She served as co-chair on the Payment for Clinical Experience Task Force and has been actively involved in the regional networking sessions at ELC. Her primary focus as DCE is in development of clinical sites, mentorship of clinical instructors and site coordinators of clinical education, and managing integrated clinical education experiences. Dr. Wilkinson received her professional education from A.T. Still University in 1999, completed her post-professional Doctor of Physical Therapy degree in 2004, and a PhD in Physical Therapy from Nova Southeastern University in 2016. She was awarded the APTA Credentialed Clinical Trainer status in 2017. She earned board certification in pediatrics by the American Board of Physical Therapy Specialties in 2009 and was granted emeritus status in 2019. Her overall research interests are within student professional development, clinical performance assessment measures, and evidence-based practice.
