ACAPT Vice President - one to be elected - 3 year term

NAME Julia Chevan

Julia Chevan is Professor of Physical Therapy and Chair of the Department of Physical Therapy at Springfield College in Springfield, MA. Her academic credentials include a BS from Boston University in PT, a MPH in health policy and management from UMass, a MS in orthopedic PT from Quinnipiac University, and a PhD in health-related sciences from Virginia Commonwealth University. She is ABPTS certified in orthopaedic PT and was a member of the first Educational Leadership Institute Fellowship program cohort. Julia holds an appointment on the APTA Public Policy and Advocacy Committee. She is a past member of the ACAPT Finance Committee (2011-2017) and was on the ACAPT task force on communication that developed the first ACAPT website. Her service at Springfield College has included leadership roles in faculty governance as President of Faculty Senate, chair of the faculty personnel committee and of the college curriculum committee. She is a former Fulbright Scholar and is an investigator publishing health services related research. Beyond her academic work, she serves in positions of leadership on private and public boards including as treasurer and board President for a Jewish community day-school and as a member of her city's recreation commission and community preservation

CANDIDATE STATEMENT

The creation of ACAPT is a monumental achievement for academic physical therapy, and I would be honored to serve as a Director in the role of Vice President. ACAPT, while still a young organization, has rapidly coalesced with a focus on academic and clinical excellence made quite clear in the strategic planning initiatives. ACAPT's focus on identifying and evaluating best practices in physical therapy education and in particular best practices in physical therapy clinical education is paramount to our success. The pressure to meet clinic needs in a tumultuous healthcare environment should encourage us as educators to collaborate in the redesign of clinical education, but not to abrogate our responsibilities to the principles of professional education and to our institutional missions. Excellence is not an unattainable goal, how we define excellence changes with each generation of academics, and only as a cohesive and dedicated group can we define and construct a road toward excellence in physical therapy education, scholarship, and research. As director, I would commit myself to engaging with the representatives of our member institutions to ensure that all voices are heard in developing the singular voice of ACAPT as it represents our academic physical therapy community.

NAME Mike Sheldon

Dr. Sheldon earned a Master of Science in Physical Therapy from Duke University (1987) and a PhD in Public Policy from the Muskie School of Public Service at the University of Southern Maine (2012). He was a staff physical therapist at Duke University Medical Center from 1987-90. Thereafter, Dr. Sheldon joined the faculty in the Department of Physical Therapy at the University of New England (UNE) and was appointed program director in 2001. In this role, he has overseen the transition in the program from baccalaureate to master's to doctoral-level education. He is currently serving as Interim Provost at UNE. An APTA member since 1985, his service to the profession has included serving as Maine Chapter President from 1997-98, Vice Chair of the Academic Administrators Special Interest Group from 2007-2010, Chair of the Research Committee of the Section on Health Policy and Administration from 2013-14, a manuscript reviewer for Physical Therapy from 2012present, and Director on the ACAPT Board from 2014-present. Dr. Sheldon's scholarship agenda encompasses his interests in disease prevention and health promotion with a focus on occupational safety and health; public policy affecting physical therapy practice; and program implementation and evaluation.

CANDIDATE STATEMENT

Since joining the ACAPT Board, I have helped develop and implement the strategic plan and provided leadership on several groups and initiatives including the Admissions Traffic Rules Taskforce, the ACAPT policies and procedures workgroup, and the work following the clinical education summit. I have been an effective liaison to APTA Federal Affairs, and my assigned ACAPT Consortia and regional member institutions. My rationale for seeking the role of Vice President (VP) stems largely from my belief that ACAPT is truly realizing its aspiration to be the "leading voice of academic physical therapy." My experience as Director provides a firm foundation upon which to serve as VP and continuity with ongoing initiatives and priorities. The pressing issues/ initiatives that ACAPT should address are to: 1) continue its leadership in proposing solutions to complex educational systems problems (e.g. models of clinical education) and facilitating their implementation at scale, 2) hold ourselves, individually and collectively, accountable for the decisions of the body, and 3) further strengthen partnerships to help achieve strategic initiatives. ACAPT is maturing, but we are still at a critical juncture in determining whether we can act for the common good or continue to function as disparate institutions with no collective voice.

underpinnings to clinical applications and health systems implementation. We need research fellowships for faculty in physical therapy, for new faculty and for midcareer faculty. I also want to preserve autonomy and flexibility for each program to find the best ways to educate future professionals. Centrally imposed structure should be minimal. Finally, I would like to see us move towards regional and eventually national matching for clinical placements. Additionally, I am concerned with the shortage of qualified, post professionally prepared faculty.

She has taught graduate courses in neuroanatomy/neurophysiology and the management of patients with neurological impairments for 25 years. Her current research interest is in the development of valid outcomes for higher and lower functioning individuals. She has been an APTA member since 1979. Dr. Medlev currently serves as secretary of the Academy of Geriatric Physical Therapy and is an Associate Editor for the Journal of Geriatric Physical Therapy. She also serves on the Board of Trustees for the Texas Physical Therapy Foundation. Past elected offices include Secretary of the Stroke SIG in the Neurology Section. Past appointed positions include member of Neurology Section Finance Committee, member of Geriatric Section PR committee, and chair of the Academy of Geriatric Physical Therapy Bylaws Task Force.

CANDIDATE STATEMENT

Problems that PT educators face include the shortage of qualified PT faculty and academic department leaders. We need to explore alternative models for earning a PhD and models to prepare non-PTs holding a PhD to become a physical therapist. To increase the number of academic leaders, along with ELI, we need to promote positive aspects of departmental leadership. Too often leaders bemoan the difficulties of their position making these positions unattractive to future leaders. Seeking out potential leaders and planting the idea of pursuing leadership positions is important. In our departments, we need to create leadership positions providing positive administrative experiences. Finding quality clinical sites is a continuing problem that has existed since I graduated from PT school. The proliferation of PT programs has added to this critical shortage. We are exploring alternative models for clinical education and need to continue. Simultaneously, we need to develop short term solutions to move our profession to a future model developed by the BPPTCE Task Force. The nominating committee's purpose is to develop a qualified slate for ACAPT leadership. Through my APTA activities, I have met many national educators and am not afraid to ask individuals to serve. I am very interested in serving ACAPT as a nominating committee member.
