<p>Dr. Harsha Deoghare is the Associate Dean of Research and Chair of the Department of Physical Therapy Education at Western University of Health Sciences. With a PhD in Rehabilitation Science from the University of Florida and over two decades of experience, he has been dedicated to academic leadership, faculty development, and financial sustainability in higher education. A 2020 APTA Fellow in Higher Education Leadership, he has contributed to advancing excellence in physical therapy education through national initiatives, policy development, and collaborative leadership. For more than a decade, Dr. Deoghare has been actively involved in ACAPT leadership, starting with the Consortium for Humanities, Professionalism, and Ethics. He was a key member of the Task Force on Data & Technology for Program Outcomes, which established a framework for reliable data management and evidence-based decision-making, contributing to the creation of the ACAPT Center for Excellence and national benchmarking for program evaluation. As Founding Chair of the ACAPT Institute for Academic Advancement (IAA), he has led task forces on interprofessional education, student preparedness, admissions, and defining the value of DPT education. Dr. North is a Distinguished Scholar Fellow in the National Academies of Practice and has earned national awards for leadership, innovation, and influence. She serves on the Executive Committee for the Physical Therapy Academy in the National Academies of Practice and on the Board of Directors for the American Council for Academic Physical Therapy.</p> <p>In addition to her Doctor of Physical Therapy degree, Dr. North completed her PhD in Evaluation Studies and Master of Education - Community Health Educator degrees. Dr. North's scholarly and professional passions include interprofessional curriculum development and assessment, system-level approaches to organizational change, contemporary challenges in health professions education, population health, diversity in health professions, and data-informed collaborative initiatives and assessment.</p>	<p>It has been an honor to serve ACAPT as a Board Director for the past year, and I am thrilled to have the opportunity to continue growing in this role.
